Tax filers can request a transcript, free of charge, from the IRS either online or by mail

Alternative to requesting a transcript online

We recommend requesting a transcript online since that's the fastest method. If you can't get your transcript online, you can request a tax return or tax account transcript by mail instead.

What you need

To request a transcript by mail, you need your mailing address from your latest return.

What you get

- Tax return or tax account transcript types delivered by mail
- Transcripts arrive in **5 to 10 calendar days** at the address we have on file for you

✓ You will need to create an ID.me Account or Log In with an existing ID.me Account

IRS now offers a sign-in option with ID.me, which offers access to IRS online services with a secure account that protects your privacy.
ID.me is an account created, maintained, and secured by a technology provider.
If you don't have an ID.me account, you must create a new account.

- ✓ If Creating a New Account, you will need the following
 - o Full Name
 - o Email
 - o Date of Birth
 - o Social Security Number (SSN) or Individual Tax Identification Number (TIN)
 - o Phone Number
 - o Current Address
 - o Driver's License or State ID

Upon successful registration, we give you the option to "continue" and use Get Transcript Online. We'll ask you the reason you need a transcript to help you determine which type may be best for you. Get Transcript Online provides access to all transcript types and available years for you to view, print, or download from your browser.

✓ Once logged in, you will need to select a reason for the transcript, choose Income Verification or Other
