Purpose and Scope

Policy

The Alvernia University Prayer and Reflection room is a small, private, personal, reflective, prayer space for meditation and contemplation that meets the needs of persons from all faith traditions.

The room is available for individual use or small group gatherings with spiritual purpose. This would include group prayer and discussion of topics relevant to spirituality and interfaith dialogue. Groups must reserve the space by accessing the Astra Event Scheduler from the Alvernia University login Web page. The reservation schedule is posted outside the room.

Exploratory resources and other materials for spiritual reading are available for use in the room such as Bible, Torah, Quran and other devotional classics; at times other programming items such as newsletters and pamphlets may also be available to take with you.

*The room does not accommodate general library use such as individual or group study, general meeting space, and instruction, or ceremonial worship and formal religious services.

Exceptions to this policy must be requested in writing by filling out the Policy and Procedure Exception form (linked below) and submitting to the individual named in the Responsibilities section who assists with reviewing exceptions to this policy.

Policy Review
